Information on the selection of the best offer

Refers to: basic public procurement procedure without negotiations, the subject of which is the delivery of a higher-class passenger car, case number 20 / ZP / 22.

Ladies and Gentlemen,

acting pursuant to art. 253 paragraph. 2 of the Act of September 11, 2019 - Public Procurement Law (Journal of Laws of 2022, item 1710), hereinafter referred to as the "Act", the awarding entity informs that in these proceedings:

- based on Article. 239 paragraph. 1 of the Act, selected the offer No. 1 submitted by the contractor LOUYET Brussels (Chaussée de Louvain 864, 1140 Brussels) as the most advantageous:
 - 1) PRICE CRITERION the contractor offered 43 261.50 EUR;
 - 2) DELIVERY TIME CRITERION the contractor has offered a delivery within 7 months:
 - ENERGY CONSUMPTION CRITERION the contractor specified 0.068 l / km;
 - 4) CARBON DIOXIDE EMISSION CRITERION the contractor specified 155 g / km;
 - 5) POLLUTANT EMISSION CRITERION the contractor specified 0.0295 g / km;

Justification

The offer of the above-mentioned contractor presents the best quality ratio for the price. The offer was considered the most advantageous and obtained 100.00 points, i.e. in:

- price criterion 40.00 points,
- delivery time criterion 45.00 points,
- energy consumption criterion 5.00 points,
- carbon dioxide emission criterion 5.00 points,

pollutant emission criterion - 5.00 points

in accordance with the description of criteria and the method of evaluation of offers, contained in the specification of terms of the contract.

Pursuant to Art. 239 paragraph. 1 of the Act, the contracting authority selects the most advantageous offer on the basis of the tender evaluation criteria specified in the procurement documents.

In the procedure in question, the contracting authority assessed the offers according to the following criteria:

PRICE CRITERION:

PRICE (C) criterion - weight 40 points (%), calculated according to the contractor's declaration, in accordance with the Offer Form;

POST-EVALUATION CRITERION:

DELIVERY TIME CRITERION - weight 45 points (%), calculated according to the contractor's declaration, in accordance with the Offer Form;

ENERGY CONSUMPTION CRITERION - weight 5 points (%), calculated according to the contractor's declaration, in accordance with the Offer Form;

CARBON DIOXIDE EMISSION CRITERION - weight 5 points (%), calculated according to the contractor's declaration, in accordance with the Offer Form;

POLLUTANTS EMISSION CRITERION - weight 5 points (%), calculated according to the contractor's declaration, in accordance with the Offer Form.
